	RECIPIENTS OF THE DATA	Personal data may be disclosed to: i) consultant and freelance professionals; ii) subjects delegated to technical or IT maintenance; iii) banks and lenders; iv) public and/or private subjects to whom the communication of data is mandatory for legal obligations or functional to the relationship; v) shippers and logistics companies; vi) person in charge delegated by SandenVendo Europe S.p.A. to processing of personal data.										
	RIGHTS OF DATA SUBJECT	Articles from 15 to 22 of the GDPR give the data subject the exercise of specific rights, including: right of access by the data subject, right to rectification, right to erasure ("right to be forgotten"), right to restriction of processing, right to data portability, right to object, right to object to automated processing including profiling. Furthermore, the data subject can lodge a complaint with the Supervisory Authority, if he or she believes that the processing that concerns him or she violates the law in force (Article 77 of the GDPR).
